On Saturday, 04/21/12, at approximately 1600 hours, I conducted a briefing for the sobriety checkpoint that was scheduled to be deployed on Flowing Wells south of River, more specifically in front of 4651 North Flowing Wells Road. The briefing was conducted at the Sheriff's Administration Building in the Operations Center and was delivered via a PowerPoint presentation.

Once all staff members were given their assignments and completed, signed and turned in their sobriety checkpoint briefing checklist, they were directed to go to Brandi Fenton Park to attend the Mother's Against Drunk Driving candlelight vigil.

Following the candlelight vigil, the deputies were instructed to go to the 4751 North Flowing Wells location to assemble the checkpoint.

The checkpoint became operational at approximately 2045 hours and lasted until 2245 hours. During this time, there were 736 vehicles that passed through the sobriety checkpoint. There were five field sobriety tests (FST) conducted, resulting in two Driving Under the Influence (DUI) arrests.

Staff members from the checkpoint were redeployed from the checkpoint to assist the Foothills patrol deputies with several motor vehicle collisions; one of which resulted in a DUI arrest. Other deputies were redeployed to the Rincon District to address and conduct a saturation patrol in and around the area of the ongoing Pima County Fair.

Once the checkpoint was completed, deputies went to a saturation patrol in various metropolitan districts and conducted a high profile enforcement effort for the remainder of their shift.

This concludes my involvement.
