Ms. Evans, chair of the board, convened the meeting at 08:30 a.m.

Item 1 on the agenda was roll call. Attendance as listed above with Mr. Hellon appearing telephonically.

Item 2 on the agenda was the Pledge of Allegiance.

Item 3 on the agenda was the approval of minutes from the meeting held on 05/07/25. Sgt. Goritz moved to approve the minutes as submitted. Lt. Pretti seconded the motion. Motion passed unanimously.

Item 4 on the agenda was the discussion and action regarding the Application for Accidental Disability for Augustine Gonzalez.
